Must have a minimum period of general experience of 10 (ten) years in construction work. 2. Having experience in successfully completion of at least 1 (one) number of Similar nature of Building Construction work in/c Internal sanitary & Water supply arrangement and Internal Electrification works not less than Tk. 270.00 (two hundred seventy) lakh in a single work order in Government / Semi-Government/ Autonomous Organization/ Reputed Developer & Private sector organization during last 5(five) years. In case of developer Value of the concern work (Project cost) assessed by the developer should be verified by the concerned executive Engineer, Public Works Department (PWD) of that area within whose jurisdiction the work is located. The basis of calculating construction cost of the work will be based on the then "Schedule of Rates" (Plinth area Rate) PWD during the project implementation period. The tender must have a valid Electrical ABC category and supervisory license issued by the Electrical licensing board of the Govt. of Bangladesh. (a) In case of a work done under PWD, the certifying and authenticating authority shall be the concerned Executive Engineer, under whom the work has been executed. (b) In case of work done under any Government /Semi-Government/ Autonomous Bodies/ Organization other than PWD the certifying authority shall be as officer of the organization (not below the rank of Executive Engineer).
