Having experience in Successfully completion of at least 1 (one) number of building works including sanitary & watery supply and Electrification works worth not less than TK. 382.00 (Three Hundred Eighty Two) Lac in a single work order in Government/Semi-Government/Autonomous Organization/ Reputed Developer & Private sector organization during last 5 (five) years. Incase of developer Value of the concern work (Project cost) assessed by the developer should be verified by the concerned Executive Engineer, Public Works Department (PWD) of that area within whose jurisdiction the work is located. The basis of calculating construction cost of the work will be based on the then "Schedule or Rates" (Plinth area Rate) PWD during the project implementation period. The Tenderer must have a valid Electrical ABC category and supervisory license issued by the Electrical licensing board of the Govt. of Bangladesh.
		a)	In case of a work done under PWD, the certifying and authenticating authority shall be the concerned Executive Engineer, under whom the work has been executed.
		b)	In case of work done under any Government/Semi-Government/Autonomous Bodies/ Organization other than PWD the certifying authority shall be an officer of the organization (not below the rank of Executive Engineer).
		c)	In case of a work done under a Private Organization the certificate is to be obtained from the Chairman/CEO/Managing Director of the Organization about the type and nature of structure and construction including up to date payment made to the applicant and the same is to be duly verified by the concerned Executive Engineer, PWD of that area.
		d) In case of Developer:	i) Considered Developer must be a member of REHAB, Copy of membership certificate is to be submitted along with tender document. ii) The structure shall be designed by an architect having membership of the Institute of Architect Bangladesh (IAB) Which shall be approved by the competent authority like RAJUK /CDA/KDA/RDA etc. Copy of drawing having approved memo and name of Architect is to be submitted along with tender document. Documents along with qualification certificates & registration of RAJUK for Architect and Engineer to be attached with drawing. iii) The structure shall have detail structural design prepared or approved by an Engineer having minimum 5 (five) years of experience and membership of the Institute of Engineers Bangladesh (IEB) with a certification. Copy of Design sheets bearing the name and signature of the designer is to be submitted along with tender documents. Documents of Qualification of designer to be attached with the design sheet. iv) There should be legally valid agreement with the owner of the land (if applicable) Document is to be submitted along with tender document. v) Completion certificate in prescribed form to be issued by the plan approving authority duly verified by the Executive Engineer, PWD under whose jurisdiction, the work has been done is to be submitted along with tender documents.

		3.	The required average annual construction turnover shall be minimum worth TK. 794.00 (Seven Hundred Ninety Four) Lac throughout the last 5 (five) years against which certificate from NBR must be enclosed along with the tender.		
		4.	The minimum amount of Free funds (Liquid Asset/Cash flow) or credit facility shall be worth TK. 130.00 (One Hundred Thirty) Lac . Bank statement (original copy) to be submitted along with the tender. Bank statement Period should be counted 28 (Twenty Eight) days before submission of Tender, to be attached.		
		5.	The Tendering capacity shall not be less than the tender Price. Details of work underway or commitment including expected completion date must be submitted along with the tender. In this regard, any misrepresentation or omission of fact will lead to rejection of tender.		
		6.	The tenderer must enclose up to date VAT Registration certificate, Income tax certificate from the NBR, up to date Trade licence & original money receipt along with tender.
